The Association of Diving Contractors International considers it important that individual commercial divers have the ability to participate in the activities of ADCI, and for that reason have established an Individual Class of membership. This class of member serves a vital need in permitting ADCI to communicate with those who have an interest in our industry and whose input and guidance may help the Association to better promote Communications, Education, and Safety in all areas of underwater activity.

An ADCI certified commercial diver that supports the purposes of this Association and who is not operating a business in the Class of a General or Associate member may become an Individual member. An Individual Member within this class shall not be eligible to be a director nor have any voting rights with regard to this Association. However, Individual Members may be appointed to or hold positions on any special committee that may be formed.

If you operate as a Company please contact the ADCI office for a General or Associate Member application. A General member is defined by the By-laws as "Any corporation, firm, partnership, organization or other association, that provides diving or other underwater technology services as a substantial or integral part of their business." An Associate member is defined by the By-laws as one that provides services, manufacturing, supplies, goods, or is otherwise involved in business in support of that in which the General Members are engaged.

Individual members of the Association of Diving Contractors International will receive *Underwater* magazine; a regional chapter newsletter if published, periodic mailing of Safety Grams, and other data related to safety. Individual members will also belong to a regional chapter and will receive discounts at ADCI functions.
